4 **SECTION 4: First aid measures**

Description of first aid measures 4.1

General information

Move out of dangerous area. Take off all contaminated clothing immediately. Show this safety data sheet to the doctor in attendance.

After inhalation

Move to fresh air. Keep patient warm and at rest. If breathing is irregular or stopped, administer artificial respiration. If unconscious place in recovery position and seek medical advice.

After contact with skin

In case of contact, immediately flush skin with soap and plenty of water. If skin irritation occurs, seek medical advice/attention.

After contact with eyes

In case of eye contact, remove contact lens and rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Consult a physician.

After ingestion

Clean mouth with water and drink afterwards plenty of water. Do NOT induce vomiting. If unconscious place in recovery position and seek medical advice.

4.2 Most important symptoms and effects, both acute and delayed

Vapours may cause irritation to the eyes, respiratory system and the skin. May cause sensitization by skin contact. Vapours may cause drowsiness and dizziness. Symptoms: Exposure may result in reddening, tears and itching of the eyes and soreness in the nose and throat, together with coughing. Difficulty in breathing. May cause headache and dizziness. Unconsciousness. Repeated or prolonged contact with the preparation may cause removal of natural fat from the skin resulting in non-allergic contact dermatitis and absorption through the skin.

4.3 Indication of any immediate medical attention and special treatment needed

Treat symptomatically.

5 SECTION 5: Firefighting measures

5.1 Extinguishing media

Suitable extinguishing media

Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide. Use extinguishing measures that are appropriate to local circumstances and the surrounding environment.

Unsuitable extinguishing media

Do not use a solid water stream as it may scatter and spread fire.

5.2 Special hazards arising from the substance or mixture

Vapours are heavier than air and may spread along floors. Vapors may spread long distances and ignite.

Vapours may form explosive mixtures with air. Take necessary action to avoid static electricity discharge (which might cause ignition of organic vapours). Keep away from sources of ignition - No smoking. Use water spray to cool unopened containers. Container may rupture on heating.

5.3 Advice for firefighters

6 SECTION 6: Accidental release measures
